Cancellation/Refund Policy

If you don't 100% love your vanilla, we'll give you a refund on your first order (up to 1 lb of vanilla). Refunds for first-time customers are eligible within 2 months of the order date.

If your vanilla arrives damaged, please contact us by email asap (and no longer than 30 days), and send photos if possible. We'll work with you to come up with a solution.

In both cases, we will generally ask you to return the vanilla, and can send you a shipping label.

How do I initiate a return?

How long does it take to process a refund?

Once we confirm that we will offer you a refund, we will process it within 2 business days. Paypal refunds are generally quick, within 1-3 days. Most credit card refunds take between 3 and 7 business days. However, in some cases, it may take up to 14 days for the refund to appear on your credit card statement.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
